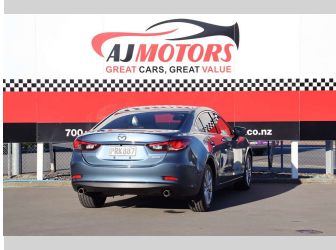

The interest rate used in this calculation is an arbitrary 13.95%, however exact interest rates vary per lender. The term of the loan used in this calculation is 48 month. These are an account admin fee of \$2.50 per month (other payment frequencies may be available) and a one-off establishment fee of \$508.00. The total amount of repayments has been calculated by multiplying 208 weekly repayments (based on a 48 month term) by the weekly repayment amount of \$81.11 which equals \$16,871.70.
