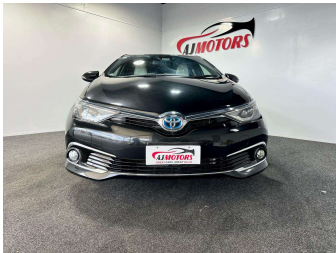

These are an account admin fee of \$2.50 per month (other payment frequencies may be available) and a one-off establishment fee of \$523.00. The total amount of repayments has been calculated by multiplying 260 weekly repayments (based on a 60 month term) by the weekly repayment amount of \$103.55 which equals \$26,922.38.
